



BORE WORK LICENCE APPLICATION

This application for a Bore Work Licence is made under section 38 of the *Water Resources Act 2007*. A bore work licence is required for any of the following:

- (a) drilling, constructing, altering, plugging, backfilling or sealing off a bore;
- (b) removing, replacing, altering, slotting or repairing the casing, lining or screen of a bore;
- (c) deepening a bore (in the course of construction or otherwise).

This does not apply to bore work that is exempt from the requirement for a bore work licence under section 10 of the *Water Resources Regulation 2007*.
