**Freedom of information request: 22/133861**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 6 October 2022, in which you sought access to information relating to Expert Panel Studies regarding City Stadium in 2022.

Your request is specifically seeking:

*"...a copy of any Expert Panel Studies undertaken in relation to the City Stadium in 2022."*

I am an Information Officer appointed under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD is required to provide a decision on your access application in accordance with section 41 of the Act, by the 3 November 2022.

**Searches conducted**

Comprehensive searches were conducted by EPSDD for documents relevant to your application. However, no relevant documentation containing information relevant to your application was identified.

**Decision on Access**

Searches were conducted using the information you provided, including additional Directorate database searches.

I am satisfied that a thorough process was completed in an effort to locate the information you are seeking. I have therefore decided, under section 35(1)(b) of the Act, that no documents are held by EPSDD that are relevant to your application.

**Online publication**

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Under the Open Access Information Scheme, documents associated with access applications are published on the disclosure log no earlier than three days after a decision on access is provided to the applicant. Documents containing your personal information will be published in redacted form to protect your privacy.

## **Ombudsman review**
