To what time is funding currently allocated to the Civic Pool? Which agency and which specific Branch is responsible for planning and developing a new pool if the Civic Pool is closed or redeveloped? Which agency and which specific Branch is responsible for managing the existing arrangements for the Civic Pool? What is the criteria for deciding whether a pool is still required for the Civic area?
