- Correspondence, briefings or minutes about the car park, or that mention the car park within EPSD or between ACT Gov directorates, entities and Ministers.
- any Cadstar references
- any correspondence to the Brindabella Christian College regarding car parking, possession, or use of the block (to or from Brindabella)
- any complaints, or enquiries, and responses about the use of the public land for car parking.
- any information about the sealing and maintenance of the car park
- anything else that indicates that the EPSDD are aware that the Brindabella Christian College, or anyone else, are using the block 23, section 41 for car parking.

The rationale is that there is no mention of the carpark in any of the documents released after mid 2016 (the carpark was sealed in late 2016). There was a flurry of correspondence and documents leading up to right before the carpark was sealed in 2016, but then it's a complete black out, even though major changes were made to the carpark! (ie it was sealed!!!). Considering that the public land is managed by ACT Government, it's reasonable to assume they'd have some awareness, notifications or internal conversations if someone built a carpark on public land.
