FREEDOM OF INFORMATION (FOI) REQUEST

I refer to your application, received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 11 June 2019 in which you sought access to information under the *Freedom of Information Act 2016* (the Act).

Thank you for your time this morning to discuss your application.

As discussed this morning, your request is amended to:

- All correspondence between the Canberra Labor Club and the EPSDD regarding the sale of Section 200 Belconnen and car parking.
- All correspondence between the Canberra Labor Club and the Suburban Land Agency regarding the sale of Section 200 Belconnen and car parking.

In accordance with section 40 of the FOI Act, the standard processing time requires that a decision on access to documents must be made within 20 working days of receipt, being 9 July 2019.
