Decision on Freedom of Information Access Application 21/114811

I refer to your application made under section 30 of the *Freedom of Information Act 2016* (the Act) received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 10 November 2021, in which you sought access to documents relating to any ministerial briefings regarding William Hovell Drive.

As confirmed on 10 and 11 November your application scope was amended.

Specifically, you are seeking:

Any ministerial briefs regarding the William Hovell Drive Duplication Project from 1 January 2018.

I am an Information Officer appointed under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD must make a decision on your application on or by 8 December 2021.

Searches Conducted

Comprehensive searches were conducted and 17 documents containing information within the scope of your application were identified.

As requested, duplicate information was not included. Documents in scope include weekly briefings, where the information in scope did not change in the following week's briefing, the brief was not included.

Decision on Access

I have included as **Attachment A** to this decision the schedule of relevant documents. The schedule provides a description of each document that falls within the scope of your application and the access decision for each of those documents.

I have decided to grant full access to 17 documents containing information relevant to your application.

My access decisions are detailed further in the following statement of reasons and the documents released to you are provided as **Attachment B** to this letter.

Please note, information considered out of scope of your application has only been redacted from the documents.

Material Considered

In reaching my access decision, I have taken the following into account:

- the FOI Act, particularly sections 6, 17, and Schedule 2
- the content of the documents that fall within the scope of your request
- information publicly available

Public Interest Considerations

My reasons for deciding not to grant access to certain documents and components of these documents are as follows:

Information Disclosure – Schedule 2 of the Act

The Act recognises the right of every person to obtain access, under its provisions, to government information (see section 7, the Act). As an Information Officer, I am required to allow access to information subject to the Act, unless, on balance, disclosure would be contrary to the public interest.

In assessing the public interest, I must apply the test outlined under section 17 of the Act which requires consideration of factors favouring disclosure, any favouring nondisclosure and the balance of those factors when considered cumulatively.

Factors Favouring Disclosure

In applying the public interest test, I have determined that disclosure of the information could reasonably be expected to do the following:

- Schedule 2, 2.1(a)(i) – promote open discussions of public affairs and enhance the government's accountability
- Schedule 2, 2.1(a)(ii) – contribute to positive and informed debate on important issues or matters of public interest.

Factors favouring Nondisclosure

In applying the public interest test, I have determined that no factors favouring nondisclosure of the information are applicable to the information in scope.

Charges

In accordance with the *Freedom of Information (Fees) Determination 2018*, no charges are applicable to this application, as the number of pages to be released is below the minimum threshold of 50 pages.

Online Publication

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application, this decision and documents released will be published in the EPSDD disclosure log no earlier than three days after you receive this decision. Your personal contact details will not be published.

Ombudsman Review

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act.
