Freedom of Information 22/08571 – Territory Leasing file Block 1/17/19 Section 26 Ainslie

I refer to your application made under section 30 of the *Freedom of Information Act 2016* (the Act) received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 24 January 2022 in which you sought access to the Territory Leasing file for Block 1/17/19 Section 26 Ainslie.

On 14 February 2022 you agreed to a clarified scope for your request. Specifically, you are seeking: *“In relation to the grant of a Crown lease over Ainslie 104 Section 26 Block 1/17/19 to the Ainslie Football Club, any correspondence regarding the operation of the Crown lease (eg changes that might be sought to vary the Crown lease or varying the zoning of the land), between the Minister and the Ainslie Football Club in the period 2015 to 2021.”*

I am an Information Officer appointed under section 18 of the Act to deal with access applications made under Part 5 of the Act.

You have granted two extensions to the due date. As such, EPSDD must decide on your application on or by 18 March 2022.

Searches Conducted

Comprehensive searches were conducted by EPSDD for documents relevant to your application.

Decision on Access

Searches conducted by EPSDD have not identified any information specific to the scope of your request. The searches were conducted using the information you provided, including additional Directorate database searches. I am satisfied that all appropriate searches were conducted and completed and therefore, there are no documents held by EPSDD relevant to the scope of your request.

Online Publication

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application and this decision will be published in the EPSDD disclosure log no earlier than three days after you receive this decision.
