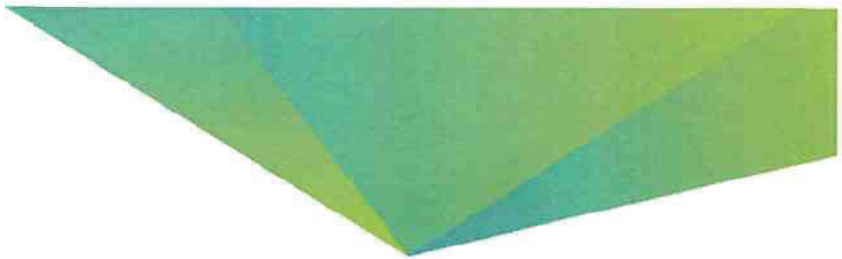

Freedom of information request: 18/21345

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 24 July 2018, in which you sought access to the Deed of Sale for Block 15 Section 36 Deakin between Zainden P/L and Croatia Deakin Football Club.

Specifically, you are seeking:

As a member of the Croatia Deakin Football Club, access the Deed for the sale of Block 15, Section 36 in Deakin. The Deed should be dated 26 June 2006 and is between Zainden Pty Limited (47111369290) and Croatia Deakin Football Club Incorporated (37207795404).

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD is required to make a decision on your access application by 20 August 2018.

Decision on access

A search of EPSDD and Suburban Land Agency (SLA) records has failed to identify any documentation in relation to your request. The search was conducted using the information you provided.

I am satisfied that appropriate searches were completed and that no documents relevant to your request are held by either EPSDD or SLA.

Online publishing – disclosure log

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application and my decision will be published in the EPSDD disclosure log after 24 August 2018. Your personal contact details will not be published.
