I write to request the following documents under the *Freedom of Information Act 2016* (FOI Act):

- Development Application no. 201732500, lodged on 22 February 2018, as well as all plans, drawings and other documents and items submitted with the application and endorsed as forming part of the minister's approval of the DA;
- information and documents received by the Planning and Land Authority (PLA) in relation to DA no. 201732500, including any advice given to the authority as a result of referral under sections 127A, 147A or 148 of the *Planning and Development Act*;
- other relevant information and documents held by the PLA not but not named above;
- as required to be lodged with the PLA for approval under section A1 of the minister's Notice of Decision for DA no. 201732500, the revised drawings based on the relevant drawings submitted as part of the application, showing:
  - electricity lines and towers to be decommissioned
  - setbacks from the proposed towers, identified on the site plan as STR 5A, STR 6A and STR 7A, to residential block boundaries
  - planting, in proximity of the residential estates, identified in mitigation measures in the Addendum to the Environmental Impact Statement (EIS)
  - details of the boundary fence for the substation, as well as
  - documents generated by the PLA in relation to these revised drawings and the authority's responsibility to grant approval thereof;
- original Environment Impact Statement no. 201700005 and any revisions of this EIS before the final EIS;
- the formal agreement between Transgrid and the Belconnen Magpies Golf Club and Woodhaven Investments Pty Ltd that is referenced in Woodhaven's submission to draft EIS no. 201700005;
- the DA for Ginninderra Estate, lodged on 9 November 2015; and
- any documents generated by TransGrid in relation to this DA for Ginninderra Estate.

I also request under the FOI Act all communications with Woodhaven Investments Pty Ltd generated or received by the ACT Government, TransGrid and/or Evoenergy in relation to DA no. 201732500 and EIS no. 201700005.

Finally, I write to request all documents regarding the minister's decision to use his call-in powers to approve DA no. 201732500, including correspondence, proposals, internal notes, and analysis of proposals, but not documents of a purely administrative nature, such as an email acknowledging receipt of a document.

I make these requests pursuant to section 30 of the FOI Act.
