### **Freedom of Information 20/12175**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 16 March 2020, in which you sought access to the Molonglo 3 Stage 2 Proof of Concept report.

Specifically, you are seeking:

*“Molonglo 3 Stage 2 Proof of Concept report (Roberts Day, March 2019). The reference to this document can be found on page 8 of Molonglo 3 East Planning and Infrastructure Study Project Brief (ACT Government, 2 February 2020)”*.

I am an Information Officer appointed under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD is required to make a decision on your access application on or by 15 April 2020.

### **Decision on Access**

Searches identified one document requested under your application as listed in the document schedule at **Attachment A**. Document schedules provide descriptions of each document that falls within the scope of an application and the access decision for each of those documents.

I have decided to grant full access to the relevant document, and it is enclosed with this letter at **Attachment B**.

### **Charges**

I have decided not to impose fees for this application in this instance and as aligned with the objects of the Act.

### **Online Publication**

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and document released to you in response to your access application will be published in the EPSDD disclosure log no earlier than three days after date of decision. Your personal contact details will not be published.

## **Ombudsman Review**

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act. You have the right to seek Ombudsman review of this outcome under section 73 of the Act within 20 working days from the day that my decision is published in the disclosure log, or a longer period allowed by the Ombudsman.
