Freedom of Information 22/89174

I refer to your application made under section 30 of the *Freedom of Information Act 2016* (the Act) received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 8 July 2022 in which you sought access to the Molonglo Valley Active Travel Masterplan.

Specifically, you are seeking:

"...a copy of the Molonglo Valley Active Travel Masterplan"

I am an Information Officer appointed under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD must make a decision on your application on or by 5 August 2022.

Searches Conducted

Comprehensive searches were conducted by EPSDD's Development and Implementation teams for documents relevant to your application. However, no relevant documentation containing information relevant to your application was identified.

Decision on Access

Searches were conducted using the information you provided, including additional Directorate database searches. The Development and Implementation team has advised that the Molonglo Valley Active Travel Masterplan has not been completed at this time.

I am satisfied that a thorough process was completed in an effort to locate the information you are seeking. I have therefore decided, under section 35(1)(b) of the Act, that no documents are held by EPSDD that are relevant to your application.

Online Publication

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application and this decision will be published in the EPSDD disclosure log no earlier than three days after you receive this decision. Your personal contact details will not be published.
