### **FREEDOM OF INFORMATION REQUEST**

This is a request on behalf of the [REDACTED]  
[REDACTED] for the purposes of the *Freedom of Information Act 2016*.

This FOI request relates to the application by Canberra Grammar School to extend its use indefinitely, of a temporary car park on land zoned as Urban Open Space (PRZ1).

I request copies of the following documents:

1. All documents, whether in physical or electronic form, relating to permission for the Canberra Grammar School (CGS) to utilise the urban open space (PRZ1) on the eastern side of Monaro Crescent opposite Canberra Grammar school (Blocks 29 and 30, Section 88), correspondence to and from CGS before and after granting permission relating to terms of use of the urban open space (PRZ1), provision for parking, storage of equipment, requirements to consult the community and any existing users of the site including informal dog-exercise groups, use of buildings and other infrastructure on or around the oval, and fees or other payments.
2. All documents, whether in physical or electronic form, relating to permission for the Canberra Grammar School (CGS) to install a temporary car parking site adjacent to the Flinders Way oval fronting Monaro Crescent, including correspondence to and from CGS before and after the grant of permission, terms and conditions of use including period, make-good provisions, and fees, as well as any requirements to consult the community.
3. All documents, whether in physical or electronic form, relating to permission for the Canberra Grammar School (CGS) to extend its period of use of the temporary car parking site on the eastern side of Monaro Crescent opposite the

CGS, including correspondence to and from CGS before and after the grant of permission, revised terms and conditions of use including period, maintenance obligations, make-good provisions, and fees, as well as any requirements to consult the community.

4. All documents relating to permission for the Canberra Grammar School (CGS) to convert the temporary car park, on the eastern side of Monaro Crescent, opposite the CGS, to a permanent car park, including correspondence to and from the CGS before and after the grant of permission, terms and conditions of use including period, fees, maintenance obligations, make-good provisions, and future ownership, as well as any requirements to consult the community and any other users of the site.
5. All formal and informal notes and records of conversations or meetings made by government officials in negotiations with the Canberra Grammar School (CGS) relating to the oval, and to car parking facilities on the eastern side of Monaro Crescent opposite the CGS, whether in physical or electronic form.
