Freedom of information request: 18/23283 - DA 201732788 correspondence EPSDD, applicant and lessee B10 S11 MACQUARIE

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 10 August 2018, in which you sought access to development application documents.

Specifically, you are seeking:

"copies of correspondence, resubmitted plans and records of communications between the Directorate for Environment and Planning and Sustainable Development and the development applicant, Canberra Planning Pty Ltd, and [REDACTED] relevant to this development application, between the dates of 16th April and 10th August 2018."

I am an Information Officer appointed under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD is required to make a decision on your access application by 6 September 2018.

Decision on access

Searches were completed for relevant documents and eight documents were identified that fall within the scope of your request.

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant full access to all relevant documents. The documents released to you are provided as **Attachment B** to this letter.

Out of scope information has been redacted from one document.

Online publishing – disclosure log

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the EPSDD disclosure log no sooner than three days after the date of decision.
