Description of the information:

The information contained in the listed documents relates to and includes information that was used by Cabinet members during Cabinet deliberation. The list includes documents that also contain information that is legal advice or opinion provided by a legal professional in relation to the activities of the Asbestos Response Taskforce, and information that relates to the specific business affairs of private individuals performing activities on behalf of the Asbestos Response Taskforce.

Grounds for decision to refuse access:

I have decided that access to this information would **not** be made available because it is taken to be contrary to the public interest under schedule 1 of the *Freedom of Information Act 2016* (the FOI Act).

The relevant grounds under schedule 1 of the FOI Act and the reasons why they were applicable in this case are outlined below:

• The information is considered to be information subject to legal professional privilege under schedule 1.2. The information is contrary to the public interest because the documents relate to legal advice has been provided to the Asbestos Response Taskforce in relation to elements of its operations and practices.

I have decided that information contained in 04/15438 - D036 should not be disclosed because, on balance, it would be contrary to the public interest, as per the test set out in section 17 of the FOI Act.

Factors favouring disclosure of this information, as outlined in schedule 2 included:

 reveal the reason for a government decision and any background or contextual information that informed the decision. The document reveals the detailed proposal for the facilitation of risk assessment workshops for the Asbestos Response Taskforce, which includes the methodology and approach proposed for the workshops supporting the operations of the taskforce which would outline and provide information relating to the contextual information for activities undertaken.

Factors favouring non-disclosure of this information, as outlined in schedule 2 included:

- 2.2(a)(ii) Prejudice the protection of an individual's right to privacy or any other right under the *Human Rights Act 2004*
- 2.2(a)(xi) Prejudice trade secrets, business affairs or research of an agency or person.

The documents contain business-specific information provided as part of a tendering process and include information relating to the proposed plan, methodology and approach to facilitating workshops, with reference to previous experiences and details of other organisations.

On balance, I consider release of the information to be contrary to the public interest, because the release of this information would unreasonably disclose the business's confidential information supplied in a tendering process, with the identification of methodology and approach potentially revealing commercial practices of the business. While the information can be reasonably considered to provide contextual details regarding the business, the public identification of the business's clients and experience may disadvantage the organisation.

If disclosed, I consider the harm to the public interest that can reasonably be expected to occur could include prejudicing an individual's right to privacy (such as a revealing individual's name, contact details and experiences), as well as unreasonably impacting on the business's commercial activities.

Review rights:

Ombudsman review

The decision to withhold this information is a reviewable decision as identified by schedule 3 of the FOI Act.

Open Access Information release outcome decision: Partial access granted

Description of the information: The documents described in the schedule relate to broad range of functions and activities undertaken by the Asbestos Response Taskforce (the Taskforce) relating to loose-fill asbestos management and remediation efforts of affected properties in the ACT.

The original record of these documents contains information the release of which would be contrary to the public interest. This information has been deleted from this publicly available copy of the documents for the reasons outlined below.

Grounds for decision to withhold disclosure:

Certain information has been redacted before the publication of these documents, as marked, because it is taken to be contrary to the public interest information under schedule 2 of the *Freedom of Information Act 2016* (FOI Act).

I have decided that this information should not be disclosed because, on balance, it would be contrary to the public interest, as set out in the test in section 17 of the FOI Act.

Factors favouring disclosure of this information, as outlined in schedule 2 include:

- Schedule 2, item 2.1(a)(i) promote open discussion of public affairs and enhance the government's accountability
- Schedule 2, item 2.1(a)(ii) contribute to positive and informed debate on important issues or matter of public interest
- Schedule 2, item 2.1(a)(iii) inform the community of the government's operations, including the policies, guidelines and codes of conduct followed by the government in its dealings with members of the community
- Schedule 2, item 2.1(a)(viii) reveal the reason for a government decision and any background or contextual information that informed the decision
- Schedule 2, item 2.1(a)(xi) reveal environmental or health risks or measures relating to public health and safety.

The information contained within the identified documents relates to the operations and activities of the Taskforce in dealing with and managing the effects of loose-fill asbestos ("Mr Fluffy") houses in the ACT. This information contains planning, reporting and legislative drafting activities which demonstrate how the Taskforce established, executed and fulfilled its mandate over the course of several years. Also included is information relating to community engagement, education and communication in assisting residents and industry in assessing and managing loose-fill asbestos.

Factors favouring non-disclosure of this information, as outlined in schedule 2 include:

- Schedule 2, item 2.2(a)(i) prejudice the collective responsibility of Cabinet or the individual responsibility of members to the Assembly
- Schedule 2, item 2.2(a)(ii) prejudice the protection of an individual's right to privacy or any other right under the <u>Human Rights Act 2004</u>

• Schedule 2, item 2.2(a)(xi) - prejudice trade secrets, business affairs or research of an agency or person

On balance, I consider the release of this information to be contrary to the public interest, because release of the information would reveal the basis of discussion or decision made through the Cabinet process where the information is provided to support the Cabinet decision-making function, identify personal details when legitimately engaging with the Taskforce or reveal business practices and processes of services providers engaged by the Taskforce.

If disclosed, I consider the harm to the public interest that can reasonably be expected to occur includes unreasonably disclosing the personal information of a person's contact details and address, undermining the proper process of Cabinet and hindering or limiting the commercial interests of service providers who performed work for the Taskforce.

Review rights:
