### **Freedom of Information Request 18/02916 – DA201732602 Block 2, Section 29 Wright**

I refer to your application under section 30 of the *Freedom of Information Act 2016* (the Act), received by the Environment, Planning and Sustainable Development Directorate (EPSDD) on 30 January 2018, in which you sought access to shadow diagrams on Block 2 Section 29, Wright.

Specifically, you are seeking:

*'Shadow diagrams for Development Application 201732602'*

I am an Information Officer appointed by the Director-General under section 18 of the Act to deal with access applications made under Part 5 of the Act.

EPSDD is required to provide a decision on your access application by 26 February 2018.

#### **Decision on Access**

Searches were completed for relevant documents and 2 (two) documents were identified that fall within the scope of your request.

I have included as **Attachment A** to this decision the schedule of relevant documents. This provides a description of each document that falls within the scope of your request and the access decision for each of those documents.

I have decided to grant full access to all relevant documents. The documents released to you are provided as **Attachment B** to this letter.

#### **Online Publishing – Disclosure Log**

Under section 28 of the Act, EPSDD maintains an online record of access applications called a disclosure log. Your original access application, my decision and documents released to you in response to your access application will be published in the EPSDD disclosure log from 3 days after the date of decision. Your personal contact details will not be published.

## **Ombudsman Review**

My decision on your access request is a reviewable decision as identified in Schedule 3 of the Act.
